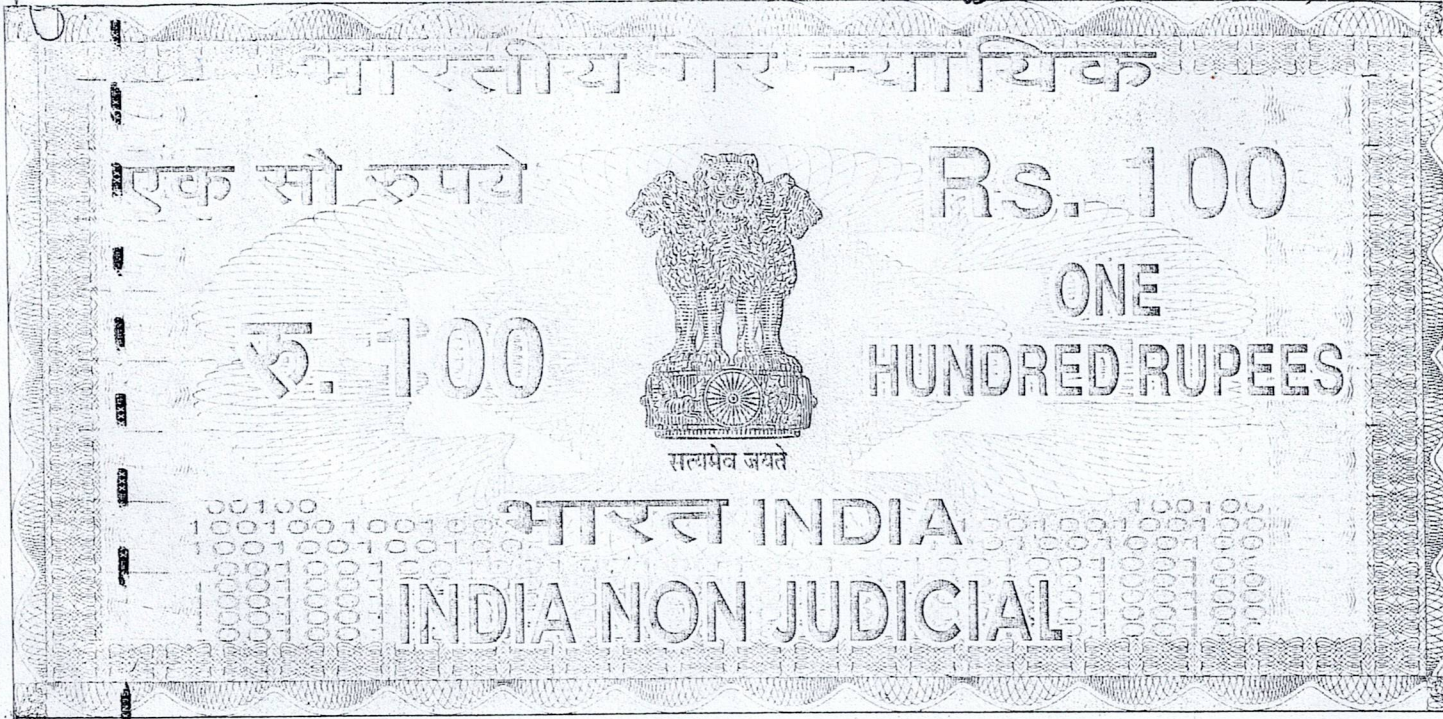

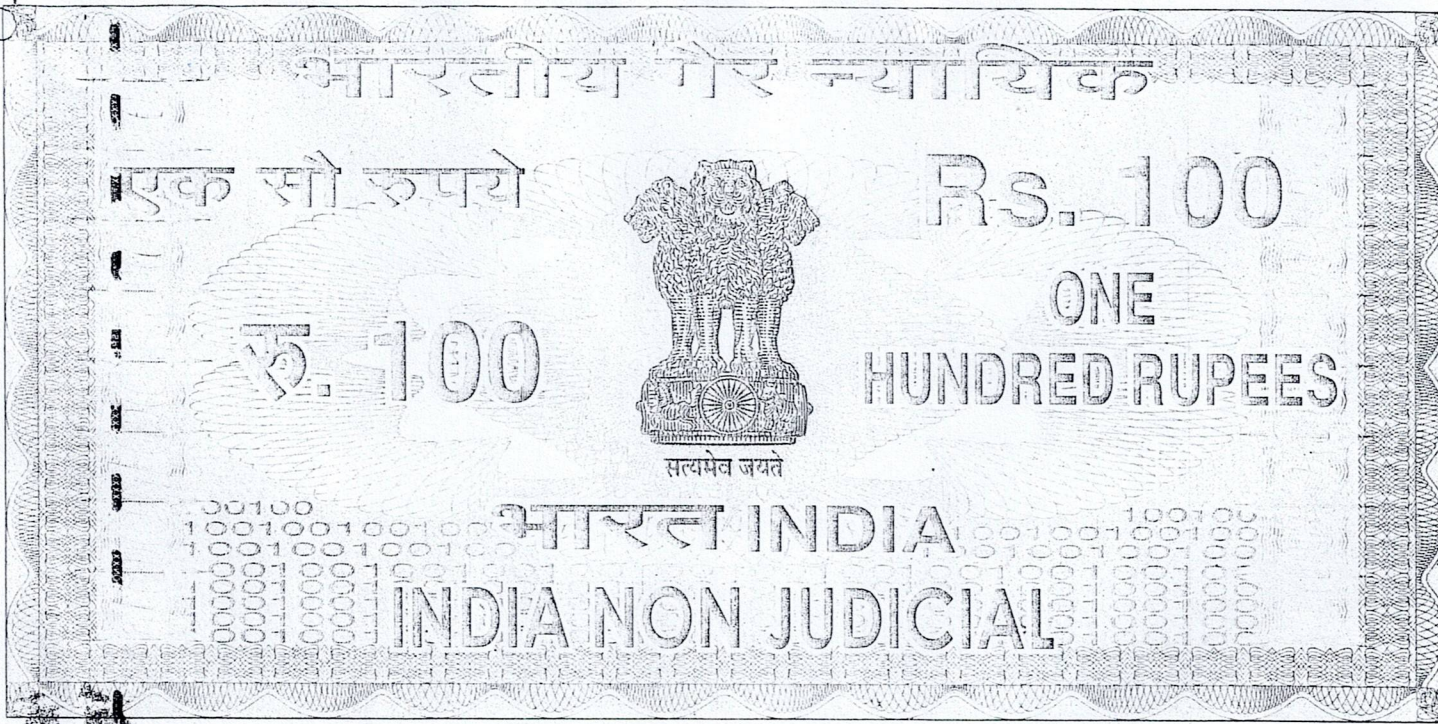

1. NAME OF THE TRUST :

The Name of the Trust is 'SHRI BHOOPATHYRAJU EDUCATIONAL TRUST' Chennai - 120.

2. OFFICE :

The Registered office of the Trust shall be Sri Sai Vidyalaya Campus, Padmavathy Nagar, Athipattu, Chennai-600 120.

3. OBJECTS :

The Trust shall be a telugu Public Educational Trust with the following objects :

- (i) The main object of the Trust is to render philanthropic and educational services to public whose mother tongue is Telugu and others who are living in villages who suffer from social and economic backwardness.

- (ii) To serve the cause of rural and community development by giving educational and technical education to the rural people by starting Matriculation School, Polytechnic and Engineering college, taking over the existing engineering polytechnic and dental colleges which could not be run by the Trust which established them on account of various reasons.
- (iii) To provide fair opportunities to the middle class Telugu Public and other community students of the Chennai, Chingelput, South Arcot, and North Arcot districts, and other places to pursue their technical education without any economic and other difficulties.
- (iv) To render financial and other necessary assistance to the taken-over professional colleges and continue to run and administer those professional colleges taken-over by this Trust and thereby serve the cause of education.

4. TRUST FUND :

The Founder hereby declares that a sum of Rs.1,000/- (Rupees One thousand and one only) handed over in Trust and dedicated for Public, educational purposes, shall be held by the Trustee upon Trust and also any other money or properties which the Trust may acquire from time to time for augmenting the Trust Fund.

5. THE FOUNDER TRUSTEE :

1. The Founder Trustee shall be **Mr.K.S.JAGADESH**, residing at **Sri Sai Vidyalaya Campus, Padmavathy Nagar, Athipattu, Chennai-600 120** The Founder Trustee **Mr.K.S.JAGADESH** shall hold office for life. He is entitled to nominate him successors who shall also hold office for life with similar power of further nomination. The founder Trustee nominates

as Trustees. The 3 Trustees nominated by him shall hold office for life. The Founder Trustee shall have power to nominate more Trustees from time to time for such period or periods as the nomination may provide and the Founder Trustee will also have the power to remove such Trustee nominated by him before the expiry of the period for which they were nominated.

6. (i) The Founder Trustee shall be the Managing Trustee.
- (ii) The Founder Trustee/Managing Trustee shall open the bank accounts wherein shall be deposited all money and contributions received by the Trust and maintain the bank accounts. The Managing Trustee shall causes to be maintained proper books of accounts required by law and therein shall be entered a true record of receipts and expenditure of the Trust. The books of accounts shall be subject to audit periodically by a qualified chartered accountant.
- (iii) The Founder Trustee/Managing Trustee shall be the person to act for and on behalf of the Trust and to open and operate independently the bank accounts and to receive and to pay money behalf of the Trust.
- (iv) The Founder Trustee/Managing Trustee shall hand power to borrow funds for implementing from INDIAN BANK, Athipattu, Chennai-600120 or other banks or financial Institutions on the Security or without security on such interest prevailing in the banking institutions and to execute necessary security documents on behalf of the Trust for such borrowings.
- (v) The Founder Trustee/Managing Trustee shall be competent from to time to frame, make and enforce all such rules, regulations and or bye-laws not inconsistent of the express provisions of this Trust, as the founder/Managing Trustee may deem proper for securing and facilitating the administration and management in detail of the various activities and affairs of the Trust and for convening, conducting and regulating the meeting of the Trustees and for appointing sub committees and generally for the Management and administration of the Trust, estate and also from time to time to repeal, alter, amend, rescind or add to all such rules.

- (vi) The Founder Trustee/Managing Trustee shall have power or authority to appoint or engage and at their discretion, remove, dismiss, or suspend any of the officials or employees or servants in permanent or temporary or special service in connection with the work of the Trust as they may from time to time think fit and to determine their powers and duties and fix their salaries, bonus or emoluments and to require security in such instance and at such amount as the Managing Trustee may think fit.

The Founder Trustee/Managing Trustee shall also have power to found and maintain provident funds, gratuity funds, personal and other funds for any employee and make rules and regulation regarding the same.

- (vii) For the purpose of carrying out the object of the Trust, the Founder Trustee/Managing Trustee shall have power to acquire by purchase or on lease or otherwise any immovable property of any tenure and in case of vacant land, the Managing Trustee shall at liberty to erect buildings thereon and do all acts necessary and incidental thereto.
- (viii) It shall be lawful for the founder Trustee/Managing Trustee to pull down, renovate, rebuild, alter, adopt, improve, add to, develop or repair any immovable property comprised in the Trust properties and to expend thereon such money out of the Trust Fund or that income thereon as they may think fit.
- (ix) The Founder Trustee/Managing Trustee shall be entitled to enter into any agreements or covenants with owners or pension, entitled to or interested in any other properties and raise funds by way of loans by entering into agreements with INDIAN BANK, Athipattu, Chennai-600120.
- (x) The Founder Trustee/Managing Trustee shall have power to make donations from the Trust properties to carry out the object of the Trust and not contravening clauses herein above.

7. FINANCIAL YEAR :

The accounts of the Trust shall be closed on the 31st MARCH every year and statement of income and expenditure and assets and liabilities shall be drawn at the date which shall present as true picture of the affairs of the Trust.

The Trust may receive contributions and donations in cash, cheques or any kind and also immovable properties, valid receipt shall be issued for all the donations received. The Trust funds shall be invested for the betterment of the Trust in any manner as the Founder/Managing Trustee deems fit including the cash securities as recognized by the Income Tax Act in force from time to time for the use of the Trust.

8. MEETING OF THE TRUST:

The Founder Trustee shall call for meeting of the TrustBoard once in Three months by giving seven days notice. The Quorum on such meeting shall be FIVE including the Founder Trustee.

9. ALTERATION OF THE BENEFITS CONFERRED BY THE TRUST:

In the event of change of circumstances making it impossible to continue any of the schemes of the Trust, the Managing Trustee shall apply the Trust funds and the property to any other subject of like nature or to any other institutions or Trust having similar objects.

10. The Founder Trustee/Managing Trustee shall have power from time to time to alter any of its clauses as the Founder Trustee may think fit.

11. The Trust hereby declared is irrevocable.


